Science, Technology & Innovation (STI) Policy Research Initiative of PCST

Pakistan Council for Science and Technology under its "Science, Technology and Innovation (STI) Policy Research Initiative" invites policy research proposals from researchers and scholars to boost research on the issues concerning science, technology and innovation (STI) policy in the country, and to build a network of STI policy researchers in the Pakistan.

Eligibility:

- a) Researchers and Scholars both from public and private sector (working in the academia, S&T/R&D organizations and Industry) are eligible to apply.
- b) Applicants should have at least a Masters degree in science / medicine/ engineering/ social science with five years' experience.
- c) Applicants must be capable of doing independent research work related to STI policy.
- d) The officers of PCST are also eligible subject to laid down conditions.

Preparing Research Proposals:

- i. The Financial Assistance for each proposal may range from 0.1 to 0.5 million Rupees.
- ii. Proposals can be submitted in any area related to science, technology and innovation (STI) policy.
- iii. Maximum study duration should not exceed 12 months.
- iv. Research Study Proposal should be prepared on prescribed Proforma for "Science, Technology and Innovation (STI) Policy Research Initiative" available at the PCST website.
- v. Research Proposals will be selected on the basis of relevance, quality, and significance of expected policy implications. Final decision in this regard rests with PCST.

Important Information:

- ii. Proposals duly endorsed by the relevant organizational heads should reach PCST no later than **April 15, 2020**.

b) Research Area:

(It should indicate specific area under the broader area of STI policy)

c) Research Objectives:

(This section should contain bullet-wise objectives of the research study to be achieved)

d) Research Background / Questions:

(The background of the study will provide context to the information discussed throughout the research study. Background information may include both important and relevant studies. In addition, the background of the study will discuss problem statement, rationale, and research questions)

e) Research Methodology:

(In this section provide details of methodology to be used for proposed research study elaborating the methods and techniques).

f) Research Plan (including the submission dates of research report)

(It should be prepared showing start and end dates of the study as well as dates of completion of important stages of the proposed study)

g) Expected Outcomes of the Study:

(It should elaborate that what policy relevant promising results this study will produce)

h) Estimated cost: (total cost should be less than Rs. 0.50 million)

(In the estimation of cost, ONLY those activities / heads of expenditure should be included which are essential to successfully complete the study. PCST, however, reserves the right to decrease the amount for any activity or altogether remove it if it deems it unnecessary)
